Information Collection

We ask that you to provide your personal information to us when you send an e-mail to us from this website. We will maintain a record of your information at the ARCA office. ARCA employees have been instructed on maintaining the privacy of each individual and the importance of protecting personal information.

Cookies

A cookie is a piece of data that is stored on a visitor's hard drive while they are visiting this website. We may utilize a short-lived form of cookie when you visit this site.
